The petition states that the construction of said improvement is necessary and will be conducive to the public welfare. The following is the course and termini of the proposed improvement:

The Packer Creek watershed, of which the main channel is further described as follows:
Beginning at a catch basin on the south side of Sugar Ridge Road, approximately 2000 feet west of Mercer Road; thence northerly approximately 720 feet; thence easterly approximately 2000 feet to Mercer Road; thence northerly along Mercer Road approximately 9500 feet; thence easterly along SR 582 approximately 11,850 feet; thence northeasterly following the existing ditch alignment approximately 66,500 feet to the intersection of Fostoria Road and SR 163; thence easterly along SR 163 approximately 7,350 feet; thence northeasterly following the existing ditch alignment through the Village of Genoa, continuing to SR 590, approximately 52,500 feet and there terminate.

A map indicating the location of the proposed improvement has been included with this mailing.
