Prior to any excavation in the county right-of-way, the Ohio Utilities Protection Service (OUPS) must be contacted in accordance with ORC Section 3781.25 to 3781.32. OUPS can be reached at 1-800-362-2764. In addition contact must be made with the Ohio Oil & Gas Producers Underground Protection Service, OGPUPS, at 1-800-925-0988.

Open cutting of pavement shall not be permitted unless no reasonable alternate method is available. Written approval of the Wood County Engineer must be obtained. Any excavation within 5' of the existing edge of the pavement shall be backfilled with Item 304 stone or approved equal.

All work requiring men or vehicles within County right-of-way shall comply with all applicable requirements of the Ohio Manual of Traffic Control Devices and Item 614 (Maintaining Traffic) of the ODOT Construction and Material Specifications, latest editions. Failure to comply with these requirements will be cause for immediate revocation or suspension of the permit until the proper traffic control devices have been provided.

### Indemnification

I, the undersigned, for his/her successors and assigns, covenants and agree to indemnify and save the County of Wood, Ohio harmless for any and all claims whatsoever arising out of the above work and/or existence of said encroachment; and further agrees that Wood County may revoke and terminate this permission to maintain an encroachment any time at its' option; the undersigned further agrees to promptly restore said right of way to its original condition at such time as said encroachment is removed, and in the event said encroachment is removed to waive any and all claims for damages, including the repair and restoration of said right of way.
